### "Changing The Way People Drive"

#### State Requirements:

- Students must be fifteen years of age by the first class.
- Students will attend 30 hours of classroom instruction and 6 hours of behind-the-wheel drive time to earn their Traffic Safety Certificate. Students may not enroll in a course once 3 class sessions have occurred.
- A student cannot miss more than three scheduled classes and **must make-up missed classes** in accordance with Washington State class to drive session integration requirements by attending another scheduled class or scheduling a DVD viewing session that is monitored by a State certified instructor. **Classes that have been made up still count as a missed class.**
- Students have 90 days, from the class start date, to complete the enrolled course and earn their Traffic Safety Certificate. Students completing the SWERVE New Driver Training Course (including all classes and drives) will receive a Washington state Traffic Safety Certificate.
- Certificates are mailed 14 days after successful completion of the course.
- The State of Washington requires all Driver Education schools to provide customers with Washington State's Organ Donor Program pamphlet. SWERVE Driver Training will distribute this pamphlet during Class #1 of our program.

#### SWERVE Requirements/Fees:

- Students are expected to conduct themselves in a professional, responsible and appropriate manner at all times. Students can be dismissed from the course for misbehavior.
- Drives rescheduled within 2 days of a Drive Session will be charged a \$37.50 rescheduling fee.
- Students not showing up for a scheduled drive, forgetting their permit at a scheduled drive, or forgetting their corrective lenses (when required) are also subject to a \$37.50 rescheduling fee.
- Additional Drive Sessions are sometimes needed. If an additional Drive is needed students are given a preferred rate of \$99.00. Additional Drives are needed when the student poses a significant safety risk to themselves and/or other drivers and pedestrians. You will be contacted if your student is considered a risk to themselves or their community.
- All fees must be paid in full for a student to receive their Traffic Safety Certificate.
- Students are eligible for a full refund 24 hours prior to Class #1. Students withdrawing from the program prior to Class #3 are eligible for a 50% refund. There will be no refunds given after Class #3.

**Licensing Test:** SWERVE is partnering with the Department of Licensing to administer the Certified written licensing tests to students who begin our program on or after March 23, 2010. This means that in your student's class 14 session they will be given a 50 question, multiple choice, written exam. If the student passes with a score of 80% or better, they are qualified to take their Behind the Wheel test without taking the written exam at the DOL. Students must be between the ages of 15 to 17 to qualify for this testing process. If the student does not pass with a score of 80% or better, they will need to retake the written exam at the DOL. If a student misses class 14 they must make it up but the exam will not count for the DOL knowledge test. Students will have to take the knowledge test at the DOL.

Intermediate license regulations: New drivers cannot drive with passengers under the age of 20 for the first 6 months. For the next 6 months you may not carry more than 3 passengers who are under the age of 20. Exceptions being immediate family members. For the first 12 months, you cannot drive between 1 a.m. and 5 a.m. unless you are with a licensed driver age 25 or older.

**If you are attending the Reality Check:**

A full refund will be given to students withdrawing from The Reality Check more than 30 days prior to the program date. Course schedule changes less than 30 business days prior to course date will require a \$100.00 rescheduling fee. 7 calendar days prior to your Reality Check we will no longer be able to reschedule your date or process a refund if you are unable to attend. Students who fail to attend the Reality Check for which they are enrolled without rescheduling ahead of time will not be refunded or rescheduled. A licensed parent or guardian is required to attend and participate while in the vehicle with any unlicensed student. Legally students are required to have their permit or license with them and parents are required to have their license with them in order to participate.
