RETURNING STUDENTS' CONTINUOUS ENROLLMENT TUITION DOWN PAYMENT: This NONREFUNDABLE and NONTRANSFERABLE tuition down payment is required for every returning student. Families with FACTS accounts will have this payment applied to their FACTS account in January and can choose to pay in full by January 20 or in three automatic payments on January 20, February 20, and March 20. NEW STUDENT APPLICATION PROCEDURE and FEE: Submit the online application and pay the application fee to start the process. After completing the application checklist and the admissions process, you will be notified of your student's admissions status. The NEW STUDENT APPLICATION FEE: This NONREFUNDABLE and NONTRANSFERABLE application fee is a one-time fee for continuously enrolled students. If for some reason CCS denies the application, all but \$50 of fees paid to CCS is returned.

Please note: Because of potential waitlist, it is important to inquire about grade availability prior to applying.

PAYMENT DETAILS:

- Every family must set up a FACTS tuition payment account and choose a payment plan prior to finalizing enrollment at Cascade Christian Schools. For returning families, **the one-time payment option is due by July 1**. For new students, the one-time payment option must be scheduled within 30 days of being enrolled.
- Monthly FACTS Payments: Payments may be set up to be made on the **5th day or the 20th day of the month, and families may choose a 10-month (August through May) or a 12-month (July through June) pay period**. In order to select 12-month billing, families must set up their FACTS payment plan before June 5. If a payment is missed due to nonsufficient funds, then a second automatic bank payment will be attempted on the next payment date (on the 20th day if your usual payment date is the 5th day, or on the 5th day of the next month if your usual payment date is the 20th day). Your account is assessed a \$30 NSF fee by FACTS.
- Please note: Tuition payment does not fluctuate with holiday seasons, student absenteeism, or emergency school closures.

What Is Variable Tuition? Our Variable Tuition program allows us to adjust tuition rates for a family to help meet their unique financial situation. Families who apply for Variable Tuition may be able to pay less than the highest listed tuition rate. WITHDRAWAL FEE: If a student withdraws after March 1 but on or before August 15, a 20% withdrawal fee of the annual contract will be due. If a student withdraws after August 15, the family is responsible for 50% of annual tuition, plus the full year's fee for laptop and any incidental charges, less any prorated tuition assistance or other discount. For a withdrawal after December 1 to the end of the school year, the family is responsible for 100% of annual tuition, plus any incidental charges, less any prorated tuition assistance or other discount.



Over the course of a school year, there are times when it may be necessary for CCS to charge additional fees to cover the costs of events, programs, courses, activities, etc. This occurs most often when costs may vary from grade to grade or level to level, or the fee covers the cost of a chosen course or activity. Below are the estimated costs of some of the potential fees that may be incurred during the school year:

Extra Day Charge: Extra days are beyond normal contracted days of childcare and must be preapproved by the Early Learning Center office prior to attending.

Family Discount: Families with more than one child in the childcare program will receive a discount. The child with the highest tuition will pay the full rate. Each additional child will receive a 7.5% discount that will be calculated by the billing office.

Please Note: Enrollment is on a space-available basis. Once space is confirmed with campus, please allow two business days for application and financial process to be completed. Rate contract must be signed and FACTS account must be set up before child can attend.

*The contract renewal fee is waived for families who enrolled in June, July, or August of that same calendar year (first year only).
